#### THE HOWARD COX & DONALD E. CROOKS SCHOLARSHIP GUIDELINES

Thank you for your interest in our scholarship program. Please read the following guidelines and eligibility requirements carefully. All areas must be completed to be considered for the scholarship.

- 1. Applicant must be a High School Senior who will be attending an accredited four-year college or university as a full-time student.
- 2. Applicant must be a member of St Christopher's Episcopal Church or a senior at John I. Leonard High School.
- 3. A 400-word typed and double-spaced essay answering one of the assigned questions must accompany the application. (See page 2)
- 4. Include a list of all the colleges to which you have applied. Specify which colleges/universities have accepted you. If the scholarship is awarded, you will need to provide proof of registration.
  - a. Each scholarship recipient is required to provide a professional photo to be posted on the scholarship website.
- 5. Attach a description of your community service experience. A minimum of 100 hours is needed to apply.
- 6. Two written references from non-relatives must accompany your application.
  - a. The Letters of Recommendation must be provided on organization letterhead
  - b. Recommendations by an individual should have the following:
    - Name
    - Occupation Title (Profession)
    - Complete Address and Phone Number
    - Letter must be signed
- 7. Include a copy of your official High School transcript. A minimum GPA of 3.0 is needed to apply.
- 8. Include a copy of your SAT and/or ACT scores.
- 9. The scholarship award is in the amount of \$4,000.00
- 10. The scholarship funds will be distributed in increments of \$1,000.00 annually for four years.
- 11. All scholarship recipients are required to adhere to the criteria below to receive the \$1,000.00 scholarship annually.
  - a. In order to receive annual disbursements, the recipient is responsible for contacting the Scholarship Committee by June 30th of each year by email (stchristopherswpbfl@gmail.com), providing an official transcript confirming a minimum GPA of 3.0 and enrollment verification for the following school term.
  - b. Under extenuating circumstances (death/close relative, illness, loss of a job, etc.), if justified and the requirements are not met, the Committee will allow a probationary period of one semester to adhere to the guidelines & continue the scholarship.
  - c. If students fail a course(s) and fall below the 3.0 GPA, they will forfeit the scholarship.
  - d. If a student is convicted of a felony or misdemeanor, including, but not limited to, controlled substance, violence, or theft, they will forfeit the scholarship.
- 12. The decision of the Scholarship Committee is final.
